	A Co-sponsor is needed when the petitioner, does not declare enough on the taxes to sponsor the beneficiary on his
asset	income. he can ask a friend or family member to provide their taxes. The co sponsor is stating that he or she can have her ts available to keep the beneficiary from collecting Welfare or Food Stamps. This liability ends when the adjuster becomes 8 citizen or is deceased.
-	Complete Form I-864 - Affidavit of Support(prepared in our office)
-	Give Proof of Citizenship or Legal Permanent Status Copy of US Birth Certificate or Passport, (Naturalization Certificate or Green Card)
