Samples of "Briefly describe the crime:

Assault at Work

The victim, Jay Vasquez was attacked during the course of his work. The Victim was attacked by Charlie Gonzalez who was most likely under the influence of drugs. This was an attempted robbery at Jesus' work site.

Assault / Domestic Violence

The victim, Maria Range, was physically assaulted by Donald Sanchez, Sr. when returning home late from work. She received a blow to her mouth and left side of her face during an argument. This occurred in Stockton, CA on July 4, 2021. See the attached police report. The suspect, Donald Sanchez, Sr. left before police arrived to the scene. The victim was granted an Emergency Protective Order.

Attack while in custody

Randy was beaten by two of the four men harassing. He was hit multiple times with closed fists and suffered injuries to his eye and lip. He also received many punches to his body. Randy was not allowed to seek medical attention since the attackers prevented him from asking for help or calling to the deputies.

Samples of "Injury to the victim"

Assault at work

Mr. Vasquez was stricken with a large level, although he did not seek medical attention initially. He did visit the hospital eventually for his traumatic experience.

Domestic violence

The victim was punched with a closed fist in the mouth and the side of her face, leaving her jaw and lip in pain. She experienced swelling. Emergency response personnel was dispatched to the home and arrived to evaluate her. She declined transportation to the hospital and indicated she would find someone to look after her children first.

The victim reports that she woke up the next morning and she had marks and bruises on her arms from the attack. The victim reports that she was unable to pursue therapy or counseling for the trauma because she did not know that she could receive the counseling for free.

Attack while in custody

"Randy reported the crime and made a formal statement. He reported the crime as soon as he was able to get away from the attackers. He identified the men that attacked him. He has made himself available for any corroboration needed from the Office of the District Attorney or the Monterey Sherriff's office. Randy would have testified in court if the attackers had not plead guilty."
